TENDER NOTICE HIRING OF SECURITY GUARDS

Sealed Tenders are invited from well reputed and financially sound Security Firms preferably having network throughout Pakistan. The Security Company should be registered with **Income Tax Authorities (in the Active Taxpayers List), Sales Tax, SRB and EOBI etc.** (the bidder should attach copy of their necessary documents along with the request for tender). The services of Security Guards Company is required for **EOBI Head Office, Karachi and its Regional Offices located in Sindh & Baluchistan Provinces.** The period of contract will be for two years (may be continued for another year on mutually agreed terms and conditions). The Company should have at least **five (5) years working experience** in the concerned Provinces with valid NQC/license from Sindh & Baluchistan Home Departments.

The Contractor is to submit bids as per procedure of **Single Stage Two Envelopes Bidding** where the bids are to be evaluated technically first then on **financial grounds** (later) and price is **taken into account after technical evaluation as per section-37(a) of PPRA Rules-2004.** The financial bid(s) of only technically qualified bidders will be opened.
