- Names and CV's of Principal staff. (5 No. at least)
- An affidavit to the effect that the firm has not been blacklisted by any government/autonomous body.
- Details of litigation if any, in which the firm has been involved during any Consultancy Service provided.
- Copy the valid Consultancy Registration Certificate/License from the Pakistan Engineering Council/PCATP (as applicable) or from other Govt. Department(s) in the relevant field.
- The forms B-1, B-2, & B-3 of PEC documents, Standard Procedure for Pre-Qualifications of Consultants shall be duly completed and signed by consultants authorized representative.
- All information supplied should be substantiated by copies of relevant documents, letters, certificates etc.

The deadline for receipt of Applications is **15<sup>th</sup> April, 2011**. Applications received after this date shall not be entertained. A shortlist shall be finalized from the afore-given submission. Evaluation of applications shall be carried out as per evaluation criteria detailed in PEC documents "Standard Procedure for Pre-qualification of Consultants".
