Tender Notice

Employees' Old-Age Benefits Institution (EOBI) invites sealed proposals from reputable firms for improving / enhancing / developing its existing website in English and developing an Urdu website along with one year support for maintenance and training. Bidding will be conducted under National Competitive Bidding pursuant to Rule 36(b) of PPRA-2004 under 'Single Stage Two-Envelope Procedure' and is open to all eligible bidders as defined in the Public Procurement Rules 2004, that meet the following minimum qualification criteria:

1. Registered with FBR/Sales Tax and **EOBI**.
2. Must have been in web design / developing / engineering business for the last three years.
3. Should have developed at least 50 websites during the last three years (valid proof required).
4. Should have at least 5 certified web developers / engineers.

Eligible firms may obtain RFP on submission of a written application on the Firms' letterhead from the below mentioned address and upon payment of a non-refundable fee of Rs. 500/- through a Bank Draft / Pay Order in favor of Employees' Old-Age Benefits Institution (EOBI) after publication of RFP till one day before closing thereof. Tender notice is also uploaded for display on the websites www.ppra.org.pk and www.eobi.gov.pk.

A pre-proposal conference will be held on **20/5/2016** at **1100** hours in the Board Room, 8th Floor, EOBI Head Office, Karachi.

All proposals must be accompanied with the Earnest Money, equivalent to 2 % of the bid price (**to be enclosed in the financial proposal**) payable in the form of a Bank Draft / Pay Order drawn on local commercial banks in favor of Employees' Old-Age Benefits Institution (EOBI). Late submitted bids, bids without bid security and conditional bids will be rejected.

The proposals must remain valid for a period of **130 days** after opening of financial proposals.
