TENDER NOTICE **Procurement of Services for Providing Banking Services**

Employees' Old-Age Benefits Institution (EOBI) invites sealed proposals from reputable local public sector and/or private sector financial institutions/banks regulated by SBP for providing Contribution Collection and Pension Disbursement services through customized and professionally designed mechanism for a period of 5 years extendable for another 05 years subject to satisfactory performance, and with mutual consent. Bidding will be conducted under National Competitive Bidding pursuant to Rule 36 (b) of PPR-2004 'Single stage two envelope procedure' and is open to all eligible Bidders as defined in the Public Procurement Rules, 2004 that meet the following minimum qualification criteria:

- 1. Should have a network of at least 600 or more branches and presence in 95+ districts for smooth delivery of services.
- 2. Should have a network of 600 or more ATMs in 95+ districts across Pakistan.
- 3. Must offer a profit @ Policy Rate on EOBI Collection/Investment account
- 4. Should be a member of ONE-LINK community
- 5. Should have verifiable proof of a minimum Long-term rating of A+ as of December 2020

Eligible banks may obtain Bid documents on submission of a written application on the bank's letter head to the below mentioned address and upon payment of a non-refundable fee of Rs.2000/- through bank draft/ pay order in favor of Employees' Old-Age Benefits Institution (EOBI) after publication of Bid document till one day before closing thereof. Bid document is also uploaded for display on the websites http://www.ppra.org.pk; and http://www.eobi.gov.pk.

All proposals must be accompanied with bid security of Rupees One million (**to be enclosed in financial proposal**) payable in the form of bank draft / pay order, drawn in favor of Employees' Old-Age Benefits Institution (EOBI). Late submitted bids, bids without bid security and conditional bids will be rejected.

The proposals must remain valid for a period of 120 days after opening of bids.

Proposals must be delivered at the address below on or before 02nd December, 2021, at 1100 hours which will be opened on same day at 1130 hours in the presence of firm's representatives (whoever chooses to attend) in the meeting room of Board Room, 8th Floor, EOBI Head Office, Karachi.
