### CIR Internet Connectivity at EOBI Head Office, Karachi and DR-Site, Lahore

It intends to promote its benefits among stakeholders and encourage employers and employees with EOBI for availing the benefits.

Employees' Old-Age Benefits Institution (EOBI) invites applications from technically competent and financially strong companies dealing in Internet Services, **50Mbps** CIR Internet connectivity at EOBI Head Office, Karachi and **10Mbps** at DR-Site, Lahore (**for two (02) years, renewable for further one (01) year** with same terms and conditions). The bidding is being carried out under PPRA Rule 36(b) of Public Procurement Rules 2004.

#### Minimum Eligibility Criteria:

#### SCOPE OF WORK

- **50 Mbps** CIR Internet Connectivity with redundant links on Fiber from separate Hubs and additional backup on Radio link for EOBI Head Office, Karachi.
- Allocation of /28 Public IP address pool at Head Office, Karachi and /29 Public IP address pool at DR-Site, Lahore
- **10 Mbps** CIR Internet Connectivity on Fiber with backup on Fiber from separate Hubs for EOBI DR-Site located at Lahore with allocation to increase of bandwidth on demand.
- Monthly Consumption report to be shared by successful bidder.
- The successful bidder must only install brand new termination equipment.
