CIRCULAR NO. 01/2007-08

Subject: AMENDMENTS IN THE EOB ACT, 1976 THROUGH FINANACE ACT, 2007

Certain amendments have been made in the Employees' Old-Age Benefits Act, 1976 as well as Minimum Wages for Unskilled Workers Ordinance, 1969 through the Finance Act, 2007 (Act. No. IV of 2007) as notified in Gazette of Pakistan vide No. 1, 22(40)/ 2007 Legis, on 2nd July 2007(copy enclosed). As the wages for unskilled workers has been enhanced from Rs. 4,000/- per month to Rs. 4,600/- per month therefore, both Employers' and Employees' share of contribution would now be calculated on the basis of revised minimum wages as amended through the Finance Act, 2007. Accordingly contribution shall be collected with effect from 1st July 2007 as specified below:-

- i) The Employers' share of contribution .i.e. 6% of the minimum wages shall be calculated on the basis of revised minimum wages of Rs. 4,600/- which comes to Rs. 276/- per Insured person per month.
- ii) The Employees' share of contribution .i.e. 1% of the minimum wages shall be calculated on the basis of revised minimum wages of Rs. 4,600/- which comes to Rs 46/- per Insured Person per month.
- 2. In section 22B, for the words "equal to the minimum pension", wherever occurring, has been substituted with words "at the rate specified in the Schedule". Therefore on or after 01-07-2007 the survivor's pension shall be calculated on the basis of formula given in the Schedule and paid accordingly.
- 3. The amendments made through Finance Act, 2007, w.e.f.1-0702007, has brought in the following changes in the Schedule of the Act, 1976:
 - i) The *Survivors' Pension* shall, henceforth be calculated like Old Age and Invalidity Pension according to specified formula.
 - ii) All benefits shall henceforth be calculated on the basis of the "monthly" wages of the month immediately preceding retirement instead of "average monthly wages"
 - iii) The minimum pension on or after 01-07-2007 shall be Rs. 1500/- per month.
 - iv) After paragraph 2 of the Schedule a new paragraph 3 has been inserted in the Schedule which reads as under:
 - "(3) The monthly rate of old-age pension, invalidity pension and survivors pension being paid on or before first day of July, 2007, under paragraph (1) above shall be increased by fifteen per cent.".

- 4. The Regional Heads shall, therefore, ensure that:
 - a) Contributions for July, 2007 and onwards are paid on the basis of the revised rates i.e. employers' share of contribution @ Rs. 276/- p.m. and Employees' share of contribution @ Rs. 46/- p.m.
 - b) If an employer pays less than 322/- p.m. per I.P, he should be asked to substantiate the figures with PR-02A (Revised) by giving the details of wages paid for the particular month (s).
 - c) The Employers who do not pay IP's contribution or pay less than Rs. 46/- p.m. without supporting the payments with PR-02A (Revised) should be issued demands for the difference and the amount should be recovered as per Law.
 - d) Survivor's pension should be calculated on the basis of the formula given in the schedule.
 - e) Formula pension is to be calculated on the basis of the wages paid in the month immediately preceding the date of retirement and not on the basis of average monthly wages.
 - f) The contribution has been paid since July 2002 (as per the amendment of 2002) on behalf of insured person whose claim is being processed.
 - g) That the wages of an insured person has not been increased in the month immediately preceding retirement merely to allow him/her to receive unduly high pension.
- 5. A separate SOP has been issued vide IOM No. HO/B&C/Bts/1581 dated: 04-07-2007 for implementation of the revised pension rates.
- 6. This issues with approval of the Chairman.

Act No. IV of 2007

An act to give effect to the financial proposals of the Federal Government for the year beginning on the first day of July, 2007, and to amend and enact certain laws

WHEREAS it is expedient to make provisions to give effect to the financial proposals of the Federal Government for the year beginning on the first day of July, 2007 and to amend and enact laws for the purposes hereafter appearing;

It is hereby enacted as follows:—

- 1. Short title, extent and commencement:—(1) This Act may be called the Finance Act, 2007.
 - (2) It extends to the whole of Pakistan."
