"Under the powers vested in it by clause (a) of section 2 of the Employees Old Age Benefits Act, 1976, the Federal Government is pleased to allow the following additional payments to the insured persons & their survivors with effect from 1/1/2012.

- 2. It shall, therefore, be ensured that all pending claims as well as fresh claims be processed and approved shall be calculated on the revised rates. The IT Department Head Office would incorporate the additional payment allowed to all pensioners from January 2012 in the database and change the rates of pension in CBA facilitating Regions in processing of pension on revised rates.
- 3. The increase being effective from January 2012, therefore, arrears of pension are to be paid to those pensioners who have withdrawn their pension till May 2012. The IT Department EOBI Head Office would incorporate arrears to be paid to the pensioners who have received
